

# **Privacy Notice**

## related to the cookie management of the mbvk.hu website and its subpages

## What is the aim of this privacy notice?

The **Hungarian Association of Judicial Officers** (hereinafter referred to as the "MBVK") uses cookies on its website and on the subpages of its website under the domain mbvk.hu. Cookies store and transmit information about the behaviour and preferences of the users of the website, hereinafter referred as Data Subjects, to the web server via the users' browser in order to ensure user customisation when using the website. A group of cookies collects statistical data on the use of the site for the MBVK only if the given explicit consent is garanted by the Data Subjects. Given the fact that the data collected and used are personal data, MBVK is obliged to comply with the obligations and grant the rights set out in Regulation (EU) 2016/679 of the European Parliament and of the Council (hereinafter *GDPR*).

This notice provides information to Data Subjects on the most important features and circumstances of data processing. The terms used in this notice shall be understood in accordance with the definitions set out in Article 4 of the GDPR and the Act CXII of 2011 on the Right of Informational Self-Determination and Freedom of Information (*Infotv.*).

#### More information about data processing

Cookies are small data files that are placed by the browser on the user's computer or device in order to collect information, record the visitor's personal preferences and then, when the website is opened, transfer the collected data to the relevant web server, thus ensuring that the user of the website does not have to customise the website used each time. This works by the browser sending a previously saved cookie back to the web server on a repeat visit, and the cookie server linking the user's current visit to previous visits and applying the preferences of the previous visit or collecting data on the use of the website.

#### Cookies can be:

- based on functions:
  - essential for the site to work,



- preference type;
- based on the time of data collection and storage:
  - active only for the duration of the session,
  - active for a limited period of time,
- based on the service provider:
  - MBVK's or
  - third source.

Without cookies, which are essential for the functioning of the website, the services provided on the website or some of the services will not function.

### What is the purpose of the processing?

## We use cookies that are essential for the functioning of the site to:

- O These cookies ensure that the user is connected to the right service after we update the server running behind the website (e.g. to avoid having to accept the cookie policy again and again, to list results after a search);
- These cookies show when the user logged in to the website;
- o Directs the user to different services or specific servers during the session;
- These cookies provide a record of the user's preferences (e.g. if the user sets the criteria for sorting the results in the auction system);
- These cookies ensure that the information already typed is remembered when the user navigates to different pages during browsing and then navigates back to the interface (search parameters);
- o Its recognises the user when they log in to the auction system and navigates away, but logs back out within a specified time.

This type of cookies is active for a limited period of time or until the end of the session.

#### We use **preference cookies** to:

o collect information about how a user uses our website (e.g. what pages they view, how long they browse a page, or if they experience any errors).

These cookies are from a third party (Google Ireland Limited ) and that are active for a limited period of time. By using Google Analytics, - provided by Google Ireland Limited- for statistical purposes, the Hungarian Association of Judicial Officers collects information about the number, frequency and use of its websites by visitors. The data is used to improve the website and the user experience.

When using Google Ireland Limited's Google Analytics service, Google Ireland Limited may also transfer your data to countries where law do not ensure that the level of protection of natural persons guaranteed by GDPR is do not undermined.

In practice, this means that you are not guaranteed that:

- practice your right to information and access to personal data (for example, there is no guarantee that you have right to obtain information, rectification or erasure from the controller);
- controllers are subject to the same obligations and they are responsible for compliance with them to the same extent as, for example, controllers in the European Union (e.g. whether they are required to take security measures, report incidents etc.);
- the authorities or supervisory authorities of that country have the same powers against data controllers or as data subjects' advocates, such as the supervisory authorities of EU Member States.

## What is the legal basis for processing personal data under the GDPR?

In the case of cookies that are essential for the operation of the site, the legal basis for processing is Article 6 (1) b) of the GDPR, i.e. processing is necessary for the performance of the agreement between the MBVK and the website visitor as set out in the General Terms and Conditions of Service (hereinafter: GTC), or in the case of the sub-site of an electronic auction system, the Terms of Use. In the GTC and the Terms of Use, the MBVK sets out its commitments in relation to the operation of the site, the rights and obligations of users in relation to their visit to the site. The cookies necessary for the operation of the site are essential for the fulfilment of the MBVK's obligations in relation to the operation of the site.

In the case of preference cookies, the legal basis for processing is Article 6(1)(a) of the GDPR, i.e. the data subject's consent to the processing for one or more specific purposes. The Data Subject is entitled to withdraw his or her consent at any time by clicking on the "cogwheel" icon in the corner of the website, exclusively in relation to websites operated by the MBVK, or by changing the settings of his or her browser (general prohibition of cookie management or prohibition of specific cookies). You can also use the "help" function of your browser to help you delete, enable and manage cookies, and for more information, please visit https://www.wikihow.com/Disable-Cookies, which provides comprehensive information on how to disable cookies and delete cookies on your computer.

Please be informed that the withdrawal of your consent does not affect the lawfulness of the processing activities and operations carried out on the basis of your consent prior to its withdrawal.

## Who has access to the personal data processed, who are the recipients of the personal data?

The personal data processed by the MBVK may be accessed by those employees of the MBVK who are required to receive, register and reply to the request on the basis of their job duties.

### What are your rights in relation to the personal data processed by the Faculty?

Where the MBVK processes your personal data, you have the following rights in relation to the processing. The deadline for completing the request (unless extended) is one month at most from the date of receipt of the request.

#### Right of access

On the basis of the data subject's right under Article 15 of the GDPR, you may request information and feedback from the controller on the conditions and circumstances of the processing of your personal data. If you are a subject of a processing operation (data subject), you have the right to access the following information in addition to your data:

- Name and contact details of the controller, contact details of the Data Protection Officer,
- the purposes and legal basis of the processing,
- the recipients of the personal data and the categories of recipients,
- the time period of storage,
- what rights and remedies data subjects have relating the data process,
- information on the source of the data,
- whether the data controller performs automated decision-making, profiling, and if so, the circumstances of the automated decision-making.

As part of your right of access, you may request an electronic copy of the personal data processed about you from MBVK, free of charge, on one occasion, pursuant to Article 15(3) of the GDPR.

# Right to rectification

Pursuant to Article 16 of the GDPR, you have the right to have inaccurate personal data concerning you corrected by the controller without undue delay upon your request, and you have the right to request the completion or correction of incomplete personal data, including by means of a supplementary declaration or documentary evidence, taking into account the purpose of the processing.



#### Right to erasure

Under Article 17 of the GDPR, you have the right to request the controller to erase your personal data if:

- processing is unlawful, in particular where the processing is unlawful,
- or the purpose of the processing has ceased,
- or the further processing is no longer necessary for the purpose of the processing,
- or the period laid down by law, international treaty or legally binding act of the European Union has expired,
- or the legal basis for the processing has ceased and there is no other legal basis for the processing the erasure of the data has been ordered by law, the Authority or a court.

The data may not be erased under the conditions laid down by law, including where necessary for the exercise of the right to freedom of expression and information, for the establishment, exercise or defence of legal claims or for archiving purposes in the public interest. The data may also not be deleted if necessary for the performance of the MBVK's tasks in the public interest or in the exercise of public authority. In such a case, the Data Controller shall inform the data subject in detail of the reasons why it is impossible to comply with his/her request for erasure.

You are entitled to withdraw your consent at any time.

#### Right to restriction of processing

Pursuant to Article 18 of the GDPR, you have the right to obtain, at your request, the restriction of processing by the controller where one of the following applies:

- contests the accuracy of the personal data,
- the processing is unlawful and you oppose the erasure of the data and instead request the restriction of their use,
- the controller no longer needs the personal data for the purposes of the processing, but you require them for the establishment, exercise or defence of legal claims,
- objected to the processing, in which case the restriction will apply for the period until it is established whether the controller's legitimate grounds prevail over your legitimate grounds.

## Automated decision-making, profiling

The Data Controller does not perform automated decision-making or profiling in its data processing.

#### What redress do you have in relation to the processing activities described in this notice?

If you are concerned about the way in which the MBVK handles your personal data, we recommend that you first contact the MBVK's office either by post (1146 Budapest, Cházár András u. 13.) or by email to <a href="mbvk@mbvk.hu">mbvk@mbvk.hu</a>. In all cases, your complaint will be investigated and every effort will be made to deal with it appropriately. If, despite your complaint, you still object to the way the MBVK handles your personal data or do not wish to complain to us, you have the following rights of redress:

#### Right to lodge a complaint with a supervisory authority

Without prejudice to any other administrative or judicial remedy, any data subject shall have the right to lodge a complaint with the National Authority for Data Protection and Freedom of Information if the data subject considers that the Data Controller or a Data Processor on his behalf has committed or threatened to commit a breach of the law by its actions or omissions.

### The right to an effective judicial remedy against the controller or processor

Without prejudice to the administrative or non-judicial remedies available, including the right to lodge a complaint with a supervisory authority, all data subjects have the right to an effective judicial remedy if they consider that their rights relating to the processing of their personal data have been infringed.



The court has jurisdiction to hear the case. You can choose to bring your case before the court in the place where you live or where you are domiciled.
